FAITH IN (POLITICAL) ACTION

In my previous articles, we explored the foundational role of politics in community life, the biblical definitions of justice, *mishpat*, and *tsedaqah*, and the vision of *shalom* as a lived, communal wholeness. We have established that for followers of the Way, seeking justice and peace is not an elective; it is a baptismal vocation.

But how do we move from understanding these concepts to embodying them? How do we exercise our collective and faithful power to ensure that our communities breathe the air of *shalom*?

In the political arena, power is often viewed as the ability to dominate or control. However, as a community of faith, we understand power through the example of Jesus: it is the ability to achieve a purpose through solidarity and service.

Faithful power is collective. While an individual can advocate, the whole body is called to this vocation. When we act together, our power becomes a sign of God's promised future, moving beyond simple legality toward active restoration and the protection of the vulnerable.

Exercising faithful power means recognizing that politics means people. When we align our collective actions with the values of love, dignity, and respect, we create the conditions under which *shalom* can take hold. We live out the values of the Kingdom of God.

As we have done throughout history, from the meetinghouses of the Revolution to the civil rights movement, the church is called to step boldly into the political arena to facilitate the flourishing of all. By exercising our collective power faithfully, we ensure that

justice gives peace its substance, and peace makes space for justice to flourish.

Here are tangible ways we can exercise our collective power to cultivate the "deep peace" Jesus calls us toward:

- **Educate the Body on Local Systems:** To effectively alleviate suffering, we must first understand its cause. Host or attend town hall-style meetings to learn how local policies impact the "quartet of the vulnerable": the widow, orphan, immigrant, and poor.
- **Engage in *Mishpat* Advocacy:** Contact local representatives to advocate for policies that protect the marginalized. Focus on questions that center on the needs of the poor and the oppressed, asking how current decisions impact their daily lives.
- **Practice *Tsedaqah* through Community Partnerships:** Build relationships with local organizations that seek radical generosity and active restoration. By aligning our resources with these groups, we strengthen communities and restore the harmed.
- **Facilitate Purely Political Dialogues:** Use the church as a meetinghouse for constructive, non-partisan conversation. Invite community members to discuss challenges like housing or safety through the lens of love, dignity, and respect.
- **Utilize ELCA Resources:** Connect with the ELCA Advocacy network and review the Social Statement on Faith and Civic Life to find guidance on how our Lutheran identity informs our solidarity with those at the margins.

By taking these steps, we ensure that our faithful power is used to make justice a lived reality rather than just a concept. We do this not as a political party, but as followers of the Way who believe that every person deserves to be treated with the compassion of Christ.

CONGREGATION COUNCIL



The December Council Meeting was held on Tuesday, December 9.

The meeting began with a discussion of the survey conducted by the Search Committee as the first step in looking for an additional Pastor, Deacon or other spiritual leader to help in our church. We reviewed what the respondents felt were the strengths, weaknesses and needs as the search begins. There was a discussion of those findings and an acknowledgment that the Council will need to consider the financial aspects of the recruitment process and consider affordability of recruitment of additional pastoral care professionals.

Committees reported on the continued progress with the HVAC System. There is a committee underway to explore a contract for a service to develop an upgraded website. The Finance Committee reported that the pledge campaign conducted by the Stewardship Committee was quite successful with an increased number of pledges and increased amount of money pledged.

The Finance Committee then presented the 2026 budget which was reviewed and approved. In addition, it is an IRS requirement that the Council designate what percentage of the Pastor's compensation is housing allowance and that was also passed.

The Council is planning a retreat on Saturday, January 10.

New Business included the Pastor's Report which highlighted Sharon Powell's session on current immigration challenges in the United States, new members, Holden Evening Prayer for Advent, and a Preschool report. Carpet installation was pending for the Gathering Space area. Collections for 2025 were down

for the year although it was noted that December is traditionally a large collection month due to the holidays and because of IRA contributions at the end of the year. At the same time, with refinancing of the mortgage and other adjustments, expenses are down about ten percent.

JANUARY CONGREGATIONAL MEETING





STEPHEN MINISTRY AT ST. STEPHEN



Williamsburg Stephen Ministry Class Held at St. Stephen

You probably have already heard that St. Stephen will be hosting the Williamsburg Area Stephen Ministry Course for 2025 beginning on **Tuesday evening, January 6**. Stephen Ministry is a ministry made up of well-trained lay ministers from the congregation. They are trained in thoughtful listening and walking with those in the church who may be going through times of personal crisis or emotional distress. Women minister to women parishioners and men to men. The counseling is supervised but completely confidential. It continues as long as necessary, sometimes with weekly sessions extending for a year or more.

Stephen Ministry was introduced in St. Louis in 1975 by Rev. Dr. Kenneth Haugk, a Missouri Synod Lutheran Pastor and Psychologist. By the time of its 50th anniversary in 2025, 14,000 Protestant and Catholic congregations have developed Stephen Ministries. 2026 is the 32nd anniversary of Stephen Ministry at St. Stephen and a good number of our present parishioners have trained and served in the Stephen Ministry. Currently we have seven women and three men Stephen Ministers on "active duty." I am delighted to report that we have three women from our church participating in the upcoming class!

The Stephen Ministry classes are fairly intensive. They meet every Tuesday night from January 6 until May 26 (with time off for Holy Week). Those classes last two to two- and one-half hours and are lectures, discussions of readings, devotions, play-acting learning and small group discussions. There is also a six-hour Saturday session on May 2 as well.

Uniformly, reviews from those who have taken the course have been very good. Even those who have had patient care or counseling experience before felt that they learned new listening and caring skills that helped them going on in life.

It's NOT TOO LATE! If you would still like to get in on the course call **Bill Dichtel** at (757) 232-5334 or send a text message as soon as possible so we can get you in.

Also, if you are a prior Stephen Minister interested in reactivating, call me as well. We may have a one-hour class for this group if there is enough interest, just to re-group on the main principles of Stephen Ministry and to bring you up to date on where we are now.

GODPARENTS FOR TANZANIA UPDATE

We have received good news from Kristin Westermann regarding the three students St. Stephen supported at Hai Institute of Technology again this year:

Kristin writes:

I am happy to report that Bernadeta, Suzana, and Charles have graduated with their vocational training certificates this month (November)! The girls now have training in tailoring, and Charles is trained in masonry.



As you can see, these kids have grown a lot over the past two years. (Having three square meals a day at school may have something to do with that!) And they are much more confident, which is lovely to see.

While I don't think life is going to be a breeze for these kids going forward, they now have a skill upon which to build their futures. And they have learned entrepreneurship and life skills that will serve them well.

The two other students you sponsored at Hai Institute, Samwel and Mohammed, are now working as masons. They work with construction crews as day laborers, earning something like 10,000 Tanzanian shillings (about \$4) per day. While that doesn't sound like much to us, it makes a huge difference to them and their families. To put it in perspective, 45% of Tanzanians live on \$2.15 or less per day (which is considered extreme poverty).

I also want to convey greetings and thanks from Mr. Peniel Shali. He is an old friend of G4TZ, a civil engineer, and the founder of Hai Institute of Technology. His dream has always been to help children from poor families acquire skills to help them raise the standard of living for themselves and their families. He is very grateful for your help in sending these young folks out into the world with some training and some hope.
